CUTTING TREES; SPRAYING; SETTING POLES; CUTTING TREES; WORKING ON ELECTRICAL TO SOFTBALL FIELD SCOREBOARD; SETTING POLES IN CONJUNCTION WITH THE TELEPHONE COMPANY; ASSISTING IN THE REPLACEMENT OF THE ROPE TO THE FLAGPOLE AT THE HIGH SCHOOL; SETTING TRANSFORMER FOR NEW GRAIN BINS; INSTALLING ELECTRICAL TO AEREATORS AT CRYSTAL SPRINGS.
