## **BUDGET BILLING PROGRAM**

**RETURN BY SEPTEMBER 24, 2021**

**Fairbury Light & Water Budget Payment Plan Application Plan & Guidelines**

**2021-2022 Plan Year - October 1, 2021 to September 30, 2022**

1. Customer's account needs to be **current and paid in full**.
2. Customer needs a current 12-month history in existing residence.
3. Available to residential customers only.
4. Customer may be late **once** in a 12-month budget pay year. If late more than once in a plan year, the customer will automatically be removed from the plan. If late, the payment must be received within twelve days of the due date or the customer will be removed from the plan. If removed, the customer will not be eligible for the plan for at least 12 months and then, not until new budget payment plan year commences.
5. No interest shall be paid by the city to the customer.
6. Budget payment amount to start with the October 1, 2021 billing. Future billing cycles will be October 1<sup>st</sup> to September 30<sup>th</sup>. Next year's enrollment will be available, beginning September 1<sup>st</sup> and concluding at the end of September.
7. The budget amount is determined by calculating the average of the customer's most recent twelve-month billing amount total. Future pricing may be adjusted into the total of the next plan year's estimated total. At the end of the level payment plan year, any credit or balance owing will be rolled into the calculation for the next plan year.
8. **Fairbury Light & Water reserves the right to adjust the monthly payment amount during the current plan year if the price of energy or other costs change dramatically or if the customer's usage changes significantly.**
9. The budget payment plan will renew automatically, and level pay amount will be adjusted for the next plan year unless cancelled by the customer or Fairbury utilities.
