

ORDINANCE NO. 3101

AN ORDINANCE OF THE CITY OF FAIRBURY TO ESTABLISH RATES, FEES, AND CHARGES FOR THE USE OF THE MUNICIPAL TRANSFER STATION, AND REPEALING CONFLICTING ORDINANCES AND SECTIONS AND TO PROVIDE FOR THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF FAIRBURY, NEBRASKA:

Section 1. That pursuant to Section 54.01 of the Code of the City of Fairbury, Nebraska, rates are hereby established for depositing waste materials in the Municipal Transfer Station, as follows:

- A. Rate schedule with the fees dependent on if the customer is a resident of Fairbury, Nebraska. Residential rates are listed first followed by non-residential rates (Resident of Fairbury/Non-resident of Fairbury). The rates are valid for the entire duration of the calendar year listed. The calendar year is described as January 1 through December 31. The rates and charges set for calendar year 2024 will remain the charges for all following years unless and until another Ordinance shall have been passed setting such rates and charges.

- B. The rate for commercial haulers shall be established through contractual agreement with the commercial hauler with the base fee as described above.
- C. Grass clippings, leaves, and garden waste may be deposited at the Yard Waste Disposal Site free of charge, provided that the composition of the material so deposited consists exclusively of grass clippings, leaves, and garden waste.
- D. Trees and brush may be deposited at the Yard Waste Disposal Site free of charge, provided that the person so depositing said materials is not a commercial hauler.

Section 2. Ordinance No. 2926 and all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. That this Ordinance shall be in full force and effect from and after publication as provided by law and shall be published in pamphlet form.
